

**CITY OF LEEDS, ALABAMA
CALLED COUNCIL MEETING
AUGUST 30, 2016**

The Council of the City of Leeds, Alabama met for a Called Council Meeting on Tuesday, August 30, 2016 at 11:00AM in the Leeds Civic Center Meeting Room, 1000 Park Drive, Leeds, Alabama 35094.

1. CALL TO ORDER: Mayor David Miller called the meeting to order at 11:00 AM with Councilmembers Johnny Dutton, Devoris Roscha Ragland-Pierce, Eric Turner, Craig Wadsworth and Kenneth Washington present.

2. INVOCATION AND PLEDGE OF ALLEGIANCE: the invocation was given by Councilmember Dutton.

Mayor announced that the purpose of the meeting is to officially canvass the results of the Municipal Election held on August 23, 2016 which is required to be completed by 12 Noon seven days after the Municipal Election referenced by State Of Alabama Code Section 11-46-55, Code of Alabama 1975.

3. CANVASS PROCEDURE:

Sealed Provisional ballot boxes for all three counties were opened by City Attorney Brunson:

a) Shelby County: no provisional ballots were cast.

b) Jefferson County: 12 provisional ballots cast; Four (4) ballots were directed by the County to be counted and Eight (8) were disallowed by the County Board Of Registrars due to irregularities. 1 ballot for Pierce and Tawbush, 1 ballot no vote for mayor and for Tawbush, 1 ballot vote for Ramsey and No Mayor, 1 ballot for no vote mayor and vote for Ramsey.


c) St. Clair County: Nine (9) provisional ballots cast and five (5) ballots were counted, one (1) was fed into the voting machine. The Provisional ballot that was mistakenly run through the tabulator machine on election day was determined by the St. Clair Board of Registrars allowed to be counted. 1 ballot vote for Miller Mayor and vote for Miller district 5, 1 ballot vote for Miller Mayor, 1 ballot vote for Miller Mayor, 1 ballot for Miller Mayor, 1 ballot vote for Miller Mayor.

The Council enacted and signed a Certificate of Election for David Miller as Mayor. The term will begin the first Monday of November, 2016.

Mayor David Miller announced consideration of **Resolution 2016-08-15 Canvassing of Election Results**. Motion to approve Resolution 2016-08-15 by Councilmember Turner with a second by Councilmember Dutton. The motion passed unanimously.

The Mayor announced the Run-off Election for District 5 between Linda Miller and Stacy Tawbush will be held on October 4, 2016.
